Guidelines for Magnet Bus Stops:

- Elementary students may walk up to one and one-half miles to a stop, or up to two miles to the neighborhood school for a stop.
- Secondary (middle and high) stops will be placed on Express Routes with stops made only at schools or public locations near schools. Distance to stops may be greater than one and one-half miles away.
- Parents/guardians should plan for assisting and supervising children to/from/while waiting at bus stops if the distance is greater than they would want their child to walk.

APPLICATION DEADLINES:

- **June 10, 2011** is the deadline to submit this application in order to be considered for a new stop before the 2011-2012 school year begins.
- If you met the magnet application deadline (Feb. 28, 2011) but submit this form after June 10, 2011, your application will be considered in September, 2011.
- If you met the magnet application deadline (Feb. 28, 2011) but were accepted to a magnet school from a waiting list AFTER June 10, 2011, submit this application when your child is accepted and it will be processed as soon as possible.
