GUIDELINES FOR MAGNET BUS STOPS:

- **Elementary** students may walk up to one and one-half (1 ½) miles to a stop, or up to two (2) miles to the neighborhood school for a stop.
- **Secondary** (middle and high) stops will be placed at or near schools, which may or may not be greater than one and one-half (1 ½) miles away.
- **Parents and guardians** should plan for assisting and supervising students to / from / while waiting at bus stops if the distance is greater than they would want their child to walk.

APPLICATION DEADLINES:

In order to be considered for a new bus stop before the 2009-2010 school year begins, you must submit this application by **JUNE 5, 2009**. Please note:

- If you met the magnet application deadline (February 27) and submit this form after June 5, your application will be considered in September 2009.
- If you met the magnet application deadline and your child is accepted to a magnet school from a waiting list AFTER June 5, submit this application. The Magnet Bus Stop Application will be processed as soon as possible.

You will be notified of your bus stop approximately two weeks prior to the first day of school via phone when your request has been processed. Please keep a copy of this completed application for your records.
